

Complaint against PC Martin - From Mr Pal - 30 October 2015

Thank you very much for your update.

REGARDING PC MARTIN'S FIRST DEALING - REF 2824378/09 (04/10/2009)

I add that PC Martin is not telling you the truth. PC Martin told us in 2010 that he didn't want to proceed with the case because the repair cost was too low to justify any court prosecution. He didn't tell us anything about false allegations. Moreover, the CCTV footage recorded the crime committed by the Australian neighbour from 111 Poynton Road. The CCTV footage clearly identified the perpetrator. We also had one independent witness from the opposite side (62 Poynton Road) who witnessed the crime and identified the same perpetrator. The fact is that PC Martin never met this independent witness and never took any statement. He never visited the perpetrator. He never took any statements from us. For 5 months, he did nothing and finally he closed the case on the ground that it was not worth to prosecute the criminal because the damages were not serious. But he never said in 2010 that it was a false allegation of crime. And today in 2015, he is telling you that it was false allegation and this is a lie.

In 2010, I complained to the Met Police about PC Martin and DI David Corbet from Directorate of Professional Standards, Colindale Police Station, Graham Park Way, London NW9 5TQ; thanked us on 15 April 2010 for our "magnanimous approach" to our complaint because we agreed with his request not to proceed with our complaint against DC Shane Martin. DI David Corbet was aware of PC Martin's dirty tricks and thanked us in 2010 for our "magnanimous approach" not to charge PC Martin because if really we had made any false allegations of crime, DI Corbet would never had thanked us.

I have already forwarded to you this email of DI David Corbet.

His email proves that we were right and PC Martin was wrong. That is why DI David Corbet thanked us. This further proves that PC Shane Martin is not telling you the truth now. There is no substance whatsoever in his claim that we made a false allegation. I am deeply concerned that PC Martin is making false statement to you and obstructing your investigation.

REGARDING PC MARTIN'S SECOND DEALING -Crimint YRRT00310800 (05/07/2013)

Although we didn't have any direct contact with PC Martin since 05/07/2013, the effect of Crimint YRRT00310800 is far-stretching misleading the Safe Neighbourhood Team who stopped believing me and didn't take any action to my concerns. This made my family suffer further. Later on a different matter (Tribunals hearing for CICA claim) DC Bent also discredited us in front of the Tribunals. All these have caused my family very serious harm, stress and damages of worth £20,000 and we request Metropolitan Police to give us compensation for our damages.

Before 05/07/2013, we had suffered from verbal assaults, stalking, racial abuses, bullying, intimidation, criminal damages of our properties and other deliberate nuisances by a family who threatened my family and the neighbourhood with knives. As a result we lived in constant stress affecting our life, work and health. We relied upon the Haringey Police and called the police on 05/07/13. PC Martin came and we reported all incidents of crime but he ignored everything and he didn't write any incidents in our police records but he discredited us by writing Crimint YRRT00310800.

We find this action of PC Martin deliberately malicious because on 05/07/13 he first came to our home, we told him all the incidents, then he went to the neighbour's home and again returned to us after 15 minutes. That was his "so-called" investigation and he didn't tell us anything about false allegations. Instead, he told us to keep Safe Neighbourhood Team (SNT) informed about any future crime. Then he wrote highly offensive, damaging content in Crimint YRRT00310800 behind our back. This is deliberately malicious because he knew that in future no police officer would believe us. Deliberately maliciously he put our lives in danger and created a hellish life for us. This cost us our work, career, quality of life and health. For these damages, we are seeking a compensation for £20,000.

After 05/07/2013, the crime continued and I reported further incidents to the SNT. But the SNT didn't believe me and didn't do anything because they were misled by Crimint YRRT00310800. This way, the police failed to protect us from crime and I had to report to the council's ASBAT Team for help. But they didn't believe me and took no action because they contacted PC Martin who had written Crimint YRRT00310800. As a result we continued to suffer until the anti-social woman burnt down her house and left in January 2015. However, we suffered terribly from crime. We lived in constant stress, we could not find work, couldn't set up our business, my daughter couldn't take rest after work and all our damages were due to Crimint YRRT00310800 and we want its removal and we are seeking compensation.

The neighbour was a bush woman from Africa, who is not aware of the laws of the UK. On 3 occasions the bush woman threatened the neighbourhood with huge 25cm long kitchen knives. It was very frightful for my daughter and wife because only 2 months ago on 22nd May 2013; Lee Rigby – a British Army soldier – was attacked, stabbed and hacked to death with similar knives. No mother gives such huge knives to her boys age 4 and 9. But she gave on 3

occasions and threatened my wife. We informed PC Martin about this life-threatening situation. But he ignored us. As a result, we had to live in a very unsafe neighbourhood and this affected our life.

The bush woman regularly stalked me and my wife in the garden and in public road. She could have attacked us with her knife. Through their open window, she could see us if we were in the garden or in the road and she would immediately follow us and howled like a dog. This greatly distressed my wife and we informed the SNT but they never took any action due to PC Martin's Crimint YRRT00310800 (05/07/2013).

Stalking and abuses flourished thanks to the police support. In January 2014 they stalked us in the garden and verbally abused us when the bush woman and her mother insulted us shouting "THE MAN IS GOOD BUT THE WOMAN IS THE PROBLEM" "WHAT IS WRONG WITH THESE PEOPLE?" "THE WOMAN IS NOT GOOD FOR ME AND I SHOULD KICK OUT MY WIFE". On another occasion, the bush woman stalked us in the garden and insulted me by calling me "ANIMAL". In May 2014, when I was with my wife in the garden, the woman stalked us again and disturbed us by very loud HOWLING LIKE A DOG and was mimicking our conversation causing us huge distress. On many occasions, we heard her talking to others mentioning my wife as "THIS WOMAN." In July 2014, the woman's mother stalked us in the garden and distressed us by making loud HOWLING LIKE A DOG. In July 2014, we left home and went to the car. Through the open window of their front room, the adults began to harass us making horrible MONKEY NOISES. This continued until we had to depart. We reported all incidents to the SNT but they ignored me due to PC Martin's Crimint YRRT00310800.

It is complete disgrace that the neighbour bush woman racially abused both my wife and me repeatedly. Without any provocation, they called me ANIMAL. Without any provocation, they harassed us by making monkey noises from their front window. Without any provocation, they laughed at my wife's breast-size and made vulgar comments why we were not having more sex to have more children. Without any provocation, they racially abused my wife that I should kick out my wife. I ask Haringey Police and PC Martin : how could you allow such racial abuses to continue? Why didn't you do anything to punish the perpetrators? What have you done for the victims? The answer is that Haringey Police and PC Martin did nothing for us, they actively supported ongoing racial abuses and instead of punishing the perpetrators, PC Martin made false allegations in his Crimint YRRT00310800. Complete disgrace for Haringey where racial abuses flourish and we have lost faith in Haringey Police.

The neighbour removed our hedges from our side. My wife grew the hedges over many years and they destroyed her hard work in one single day. They destroyed our garden property worth £800, They never showed any remorse, no apology. We had to invest further money to buy Tarpaulin screens to restore privacy. But the boys made further criminal damages to the screens by making holes. The screens cost us £50. So again we had to invest money to restore privacy and we bought wood to build a wooden barrier. During the summer, 6 or 8

teenagers disturbed the whole neighbourhood by kicking metal shed, banging from metal shed, throwing empty rubbish bins, shouting and screaming. This nuisance continued for 4/5 hours.

I couldn't prepare for job interviews and actively look for jobs. Then both of us tried to set up our business but the ongoing crime forced us to resign. I couldn't earn any money for my family and my wife couldn't continue her artistic career. As head of the family, I couldn't set up my business and couldn't earn any money to support my family because of constant stress, deliberate shouting, screaming and other anti-social behaviour of the adults. My daughter couldn't take rest after work. On summer days, we couldn't open our windows. She couldn't study, she couldn't prepare for her work. My wife is a fine artist, actress and singer. But the criminal activities of the neighbours made her life impossible to continue her creative work. The whole family suffered for 3 years.

I may sound bitter, however, this is the natural reaction of victims of prolonged harassment and we lost our work, we lost our garden property worth £800, we were being stalked and racially abused, we lived in a very unsafe neighbourhood, we could not work to earn money and finally we lost our CICA case at the Tribunal when DC Bent discredited us before the Tribunals by reading out PC Martin's Crimint YRRT00310800. We lost at least £3000 (CICA Tariff of compensation).

PC Martin is very dangerous for us and he has malicious intent to damage my family. He is dishonest and unreliable because if he really believed that we were making false allegations, he should have told us this on the face on 05/07/2013. Instead, with malicious intent, he wrote Crimint YRRT00310800 behind our back. We trusted him as a responsible police officer but he stabbed our backs like a traitor. He is a liar because in 2010 he told us one story (his reason for not proceeding with our car vandalism case was low car repair cost not justifying public interest) and today in 2015 he is telling you a different story (his reason for not proceeding with the case was false allegation). In my opinion, he is a compulsive liar and he brings only disrepute to Haringey Police. That is why DI David Corbet upheld our complaint in 2010 and thanked us for our "magnanimous approach" not to charge PC Martin because if really we had made any false allegations of crime, DI Corbet would never had thanked us. I have already forwarded this email to you.

REGARDING PC MARTIN'S THIRD DEALING

I was not aware of CrimintYRRT00326717 (17/07/2014). This is very strange because I requested Metropolitan Police for my COMPLETE police records and I didn't find any CrimintYRRT00326717 (17/07/2014) in my police records. I am going to write to them why they didn't send me this.

However, you are telling me that PC Martin had an indirect contact with us as an ISP

(Information Sharing Protocol) request from the ASBAT Team, Haringey in the form of a data protection request and this was completed and documented on CrimintYRRT00326717 (17/07/2014).

As told above, on 05/07/2013 PC Martin left my home telling me to contact the SNT in future. I did so but the SNT did nothing. So I went to the ASBAT Team, Haringey and told them to corroborate my concerns with PC Martin. At that time I was not aware of PC Martin's Crimint YRRT00310800. The ASBAT Team didn't believe me and we continued to suffer from anti-social crimes of the bush woman until she burnt down her home in January 2015.

The ASBAT Team didn't believe me because of PC Martin's CrimintYRRT00326717 (17/07/2014) which was based on Crimint YRRT00310800 (05/07/2013). That is why I request Met Police to remove this CrimintYRRT00326717 (17/07/2014) from our police records as well as Crimint YRRT00310800 (05/07/2013).

CONCLUSION

We are British citizens and we are proud to be British. We respect British values. We don't disturb anybody and we want to live in peace. Why do we have to suffer from crime and the criminal goes unpunished due to PC Martin's Crimint YRRT00310800 and CrimintYRRT00326717? We have been treated like a piece of dirt by Haringey Police who ignored our concerns and put our life into danger. That is why I seek compensation for all the damages, removal of both Crimint YRRT00310800 (05/07/2013) and CrimintYRRT00326717 (17/07/2014) and injunction upon PC Martin not to have any contact with us. The removal of both the Crimints is vital to our safety in the UK because they discredit us in our police records and in future the police will never believe us and these Crimints will always stand in the way of any future police investigation.
